

LEGAL NOTICE TO BIDDERS
ROADWAY ASPHALT MATERIALS

Sealed bids will be received by the Board of County Commissioners in and for Lake County at their office in the Lake County Administration Center, 105 Main Street, Painesville, Ohio 44077, up to the hour of **11:00 a.m.** Local Time on **Wednesday, April 15, 2009**, and read publicly thereafter in the Commissioners' Chambers at the above address, for the following roadway materials for use by the Lake County Engineer's Road Department for the year 2009:

Plant Mix Pavements

Said Roadway Materials shall be in accordance with specifications and proposal forms on file with the Clerk of the Board of County Commissioners. The Bid Package may be obtained from the Office of James R. Gills, P.E., Lake County Engineer, 550 Blackbrook Road, Painesville, Ohio 44077.

The proposal must be accompanied by an original sealed document in the form of a bid bond, or by certified check, cashier's check, or irrevocable letter of credit equal to five percent (5%) of the amount bid, drawn on a solvent bank located in The State of Ohio, and payable to the Treasurer of Lake County, Ohio, as surety that if the proposal is accepted, a contract will be entered into and its performance properly secured. Should any bid be rejected, said surety shall forthwith be returned to the bidder and should any bid be accepted, such bid bond, certified check, cashier's check, or letter of credit will be returned to the bidder upon proper execution and securing of the contract.

No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply, if the bidder is listed on the Auditor of State's Database as having a "Finding of Recovery" as that term is defined in R.C. 9.24. No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply unless the bidder has completed a certification that the bidder is in compliance with R.C. 3517.13. A copy of the certification is included with bid package, and must be executed and submitted with the bid. All contractors and subcontractors involved with the project shall comply with the provisions of R.C. 2909.33 by filing the Declaration regarding Material Assistance/Non-Assistance to a Terrorist Organization.

Proposals shall be subject to the conditions that, the right is reserved to hold bids for a period not longer than sixty (60) days after date of bid opening and/or to award the contract any time during said period.

EVERY item under Plant Mix Pavements must be bid for that bid to be considered complete.

Suppliers shall furnish Material Safety Data Sheets for any hazardous substance brought onto County property.

Proposals shall be in a sealed envelope addressed to: The Lake County Board of Commissioners, Lake County Administration Center, 105 Main Street, Painesville, OH 44077, and marked "BID FOR ROADWAY ASPHALT MATERIALS FOR LAKE COUNTY ROAD DEPARTMENT," and shall contain all documents required to be submitted.

The County reserves the right to reject any or all bids, or to increase or decrease or omit any item or items and/or to award to the lowest and best bidder. Each proposal must contain the full name of every person or company interested in the same.
