**RESOLUTION AWARDING A BID CONTRACT IN THE AMOUNT OF \$1,221,771.01 TO C.I.R. INCORPORATED FOR THE RIVER ROAD PROFILE IMPROVEMENTS REBID, PERRY TOWNSHIP, OHIO**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of County Commissioners, and that all the deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the Lake County Engineer recommended to the Board of Lake County Commissioners to advertise for bids for River Road Profile Improvements Rebid, Perry Township, OH, and

WHEREAS, bids were received by the Board of Lake County Commissioners on March 25, 2009, and said bids have been reviewed by the Lake County Engineer and he is recommending the Board to award said bid to C.I.R., Incorporated, it being the lowest and best bid received.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County, Ohio, hereby awards a bid contract to C.I.R., Incorporated, for the River Road Profile Improvement Rebid, Perry Township, OH in the amount of \$1,221,771.01. Said Contract incorporated herein and made part of this resolution by reference.


